- **Cash Gifts** – These are the simplest and most popular method of giving. They are tax deductible in a given year.
- **Gifts of Securities** – This includes stocks, bonds, and mutual funds. This can avoid capital gains taxes and provide an income tax deduction for the full fair market of long-term appreciated securities.
- **Bequests** – Establish Women Giving Back as the beneficiary of your estate. You can provide an estate tax deduction equal to the value of your gift, which allows you flexibility to provide for your family first.
- **Retirement Gift Plans** – For current gifts, consider using the IRA Charitable Gift Rollover provision for donors aged 70 ½ and older. Naming WGB as the beneficiary can help eliminate income tax on plan distributions and preserve the plan's full value for gifting purposes.
