This stewardship model reduces waste and extends the life of quality goods. • 2024 Impact: \$1,319,040 in clothing and essentials distributed to an estimated 8,794 individuals through our partner network. Diaper Pantry Program: Launched during the pandemic, the Diaper Pantry helps alleviate diaper need for low-income families. By providing free diapers and wipes, WGB supports infant health and reduces financial and emotional stress for parents and caregivers. Approximately 80% of diapers are supplied at no cost through the Greater Washington DC Diaper Bank. • 2024 Impact: 467,575 diapers distributed to 5,136 families, benefiting 6,009 infants.
